

Family Promise Day Center is open and welcoming families to their new home on the second floor of St Paul's. The families are usually at the Day Center on Sundays and have joined us during worship and /or coffee hour. The center is open Sunday-Friday 10am-3pm. Everyone is welcome to visit and meet the families.

After Covid, Family Promise (FP) developed a new model. FP rents a three bedroom house and has two travel trailers. The trailers travel to different churches every two weeks between April and September. The house is open year round.

Due to limited parking space at St Paul's we support the trailer parked at St Dunstan's Episcopal in Davison, MI. St Paul volunteers join with volunteers from St Dunstan's and St Jude's Episcopal in Fenton, MI to provide evening meals for the two weeks the trailer is parked in St Dunstan's parking lot.

How can I get involved? Our first host dates are Jan 11, 12 and 13, 2024. We will get information about the family a week before. It will include their names, ages and dietary allergies and foods they like. We prepare a meal for the family to be served starting at 5:30pm.

Because we house the Day Center at St Paul's, we have several options to host at the house.

If you like to bake, you can make items now and we can store them in St Paul's freezer. Same thing with a casserole. Just include the ingredients so we can avoid a specific food allergy. Can deliver to the church but not the house? No problem FP drives the families to the house everyday. The FP driver can take the food for the evening meal. Want to treat the family to a restaurant meal. Have one delivered to the house.

Family Promise is a ministry of the Outreach Committee. We meet the first Thursday each month at 6:30 pm. All our welcome to join. You do not have to be a part of the committee to help with Family Promise. 2024 Proposed By-Law Amendments

All have been approved by vestry to be brought forward for vote at annual meeting.

- Move to approve a motion to amend Article IV Section 1 of the St. Paul's By-laws to read "The Vestry shall be made up of six (6) seven (7) members." This amendment shall take immediate effect.
- Move to approve a motion to amend Article IV Section 2 of the By-Laws to read: "The terms of office of Vestry members shall be three (3) years, and the Vestry shall be divided into three (3) equal (or near equal) classes, one class leaving office each year.
- 3. Move to approve a motion to amend Article II Section 1 Clause C Line 4 to be thus changed:

From: <u>"To be elected, a Nominee must be voted for on a majority of the ballots</u> <u>cast. However, if it appears the election cannot be determined by majority</u> <u>vote, the Annual Parish Meeting may, by majority vote, decide that elections</u> <u>will be carried by plurality vote.</u>"

To: "To be elected, a **vestry** Nominee must be voted for on a majority of the ballots cast. **If a vote results in no candidate (or not enough candidates)** receiving a majority, then additional votes will be conducted with either those having already received a majority or the candidate with the least number of votes on the previous ballot removed from the ballot. Delegates and alternates to Diocesan Convention shall be elected by plurality vote with the highest four vote recipients elected as delegates and the next four elected as alternates." However, if it appears the election cannot be determined by majority vote, the Annual Parish Meeting may, by majority vote, decide that elections will be carried by plurality vote."

Rationale/Explanation

- 1. Increasing the vestry membership total to 7 will create an odd number of votes and thus reduce the likelihood of tie votes. The vestry has seven members currently.
- 2. The language regarding the election of three classes of three people each year dates to the traditional nine person vestry. The vestry classes would now have to be elected in classes of two, two, and three.
- 3. The St. Paul's By-Laws have always called for elections by majority, but this new language would indicate more clearly how the votes would be conducted. This new language also calls for a single, plurality vote for delegates and alternates to diocesan convention.


BLOOD DRIVE

As they say at the Red Cross, "Give blood and give the gift of life".






