- **Previous Meeting Minutes**
 - Bob moved to approve the minutes, Zan seconded.
 - No dissent
- **Finance Update**
 - Things are going normally.
 - Barth Fund
 - \$20,000 in pay outs for August
 - Increased by \$1,800
 - These funds are restricted use.
 - Diocesan Tithe is increasing due to new formulation
 - Goes into effect in December
 - Five scholarships were awarded by the Sue Kilmer Scholarship Fund
 - Bob moved to approve the minutes, Zan seconded
 - No dissent
- **Unfinished Business**
 - Trust Fund litigation
 - Stepping down of Sean O'Bryan
 - Fr. Tom sent an email saying it would be discussed at Vestry, Sean replied saying he agreed to step down.
 - Campus Ministry
 - Province V Young Adult and Campus Ministry educational/formational cohort begins September 11.
 - Rayna plans to make the ministry an ecumenical one.
 - Capital Campaign Pledge Forms
 - Vestry had not completely turned in or filled out.
 - Diocesan Technology Grant
 - \$1,000 awarded to St. Paul's

- Plan for new TV for movie night and other usage, stand for the TV, and a new lectern microphone.
 - Bell Situation
 - Church got a bill for \$38,000 instead of \$7,500.
 - This includes the work for the harness, which had not been approved by vestry.
 - Electric striker will be updated.
 - No date for finishing of the work, still hoping for October 18, 2025
 - Carpet Update
 - Skaff took measurements with Bekcy
 - \$14-17,000 estimate for cost
 - Congregation will vote at an upcoming Sunday
 - Will get another estimate from the Flint Carpet Company
 - Preaching Class Update
 - Bob got in.
- **Rector's Report**
 - Funeral
 - Good example of the work of the team
 - Mary and the Sprinklers
 - Sprinklers are now fixed
 - Mary would like to expand the sprinkler coverage to the side flowers along the side of Barth Hall
 - She will pay for the cost
 - Diocesan Convention in October
 - Elizabeth Jordan and Rayna Hauter are delegates
 - Joint Diocesan choir, including our chancel choir
 - Dalton-Johnson Organ Trust
 - Family sent a hold harmless letter to the church to break the trust
 - There is a connection to the Whiting family who we are asking for contributions to the Capital Campaign
 - Uncertainty surrounding what triggered this change from the family, will need to be investigated and understood
 - Stewardship Committee
 - Walt has agreed to chair the Stewardship Committee
- **Senior Warden's Report**
 - Report was given by Fr. Tom as TaMara was not present
 - Bishop Search Committee
 - Elizabeth Jordan is on the Bishop Search Committee
 - Bishop Transition Committee
 - Rebecca Bennett is on the Bishop Transition Committee
- **Junior Warden's Report**
 - Report was not given as Karen was not present.
- **Ministry Highlights**
 - Becoming beloved Community Grant
 - Grant was submitted to the Church
 - Crim
 - Over 500 people came for blessings or bathrooms
 - Back to the Bricks
 - Roughly \$400 in profits to be given to Family Promise once all expenses have been reconciled.
 - Yard Sale
 - At the end of September there will be a yard sale to raise funds for both Family Promise and the St. Paul's Assistance Fund.
 - After School At Risk Food Program

- Similar program to the summer Meet Up and Eat Up that was hosted by Family Promise in Barth Hall
 - Still sponsored by the Food Bank of Eastern Michigan and the Michigan Department of Education
 - Snack at 3:30 when kids arrive
 - Dinner sometime between 4:30 and 5:30.
 - Hot meals warmed up in the kitchen
 - Meals arrive frozen
 - Tuesday and Thursday only.
- **New Business**
 - Tin Can Ministry
 - Pocket change at Sunday Services after the offertory
 - Proceeds to Carriage Town
 - Modeled after similar ministry at Trinity Episcopal in Columbus
 - Bob made a request that Vestry materials such as financial reports and minutes get sent out before the meeting
 - Fire and Safety Drill
 - Emergency Preparedness and Response Ministry in development.
 - Dishwasher issues may be resolved
 - Was vapor locked and needs to be primed frequently.
